Origination of Information

- 1. Customer completes credit application

Contract Details

Document Package

Call or email your DLL representative to request the document package. Please note, the complete legal description of the land in which the Netafim material will be installed is required to be submitted to DLL in order to generate the customer document package.

 - b. Customer Credit Application
 - c. Retail Installment Contract/Lease Agreement
 - d. Authorization for Automatic Withdrawls (ACH)
 - e. Proof of Physical Damage Insurance
- 2. Document package will be system generated and sent via email/fax/overnight mail to the dealer.
- 3. Dealer is requested to check document completion accuracy.
- 4. Send a legible copy of the applicant and co-applicant valid Drivers License
